I. Call to order/Roll Call

II. Approval of minutes from last meeting

Jerry Scott made a motion to approve with edits, Tim Froncek seconded. Edits: First show on June 8th, 2020. There will be 10 jazz in the park concerts, last show will be August 10th. There will be an option for rain dates after.

III. Review and Approval of Financials for October 2019. Penni Reed motioned approval, Michelle Needham seconded. All in favor. Note: Collection of sponsorship for table sponsor occurred in September.

- 2. Record 50/50 sales, winning portion donated back to WMJS
- 3. Gumbo quality was below par this past week and they ran out of salad due to guests taking too many
- 4. More sponsors are needed, email and online positing for table sponsors
- 5. \$5 per musician to eat gumbo
- B. Holiday Party 12/16/19 at Watermark Silent Auction donations needed
- 1. About 70 attendees registered so far
- 2. \$750 for sponsoring a table with 8 seats and wine
- 3. Potential tabling for In The Blue Jazz Ensemble (quartet) to play while the main band is eating dinner. Jerry will follow up with Jake about this.
- 4. Food is comped for the band at the holiday party.

- C. Grand Rapids Federation of Musicians Grant Update
 - 1. If they allow us to submit the paperwork after each performance. If we potentially pay for three union memberships (sound technicians), we can get the grant funding from the GRFM.
 - 2. There are no requirements for all the performing musicians to be in the union

 - 1. Party is on hold until the volunteer coordinator
 - 2. Every board member needs to submit volunteer positions before the end of the year

 - 2. Jim needs membership amounts to be prorated for 2020.
