The request will be for \$20,000 for Jazz in the Park. Jordan mentioned that WMJS should include a piece about diversity, equity, and inclusion. Also, to include a message about the mission statement and increasing access for different communities. Michelle suggested adding the Juneteenth event to the grant.

A. Noto's Supper Club Wednesday, October 28th

Kevin also noted that to have well rounding programming, more inputs should be fielded so that the best programming is put in place. Jim shared the details of the first event and that the capacity would be reduced for social distancing.

B. WKTV/WMJS – JazzWorks Program

Michelle and Mary met with WKTV about a potential series on air with WMJS. Tom Norton approached WMJS about restarting their old program. They would do all of the work to produce the program and all of the work to distribute the program. They also would share in community donations, WMJS would also share in the costs. The program is 30-60 mins long, it could be weekly or monthly. There are some potential concerns with the rights to the music. Jordan suggested that WMJS starts with original music and builds up a nest egg to cover copyrighted music in the future.
