#### I. Call to order/Roll Call 9:38AM

## III. Review and Approval of Financials

WMJS is running a profit from donations in Q2 (the letter that was sent helped). In June, the award from Women who care really helped secure the bottom line for WMJS. Jim will provide financials soon as they are available. Jim also mentioned WMJS may be moving around funds into a new account to earn more interest on the balance.

### V. Open Business

- A. Jazz at Millennium Park Updates
  - 1. Over 450 attendees at the park last week, numbers have overall seen a steady increase. The collection of donation each week is near  $\sim$ \$1,000
  - 2. Individuals with mobility issues have expressed concerns about the grass/slope on the amphitheater. Others have asked to be back in the pavilion.
  - 3. WMJS has added a portable restroom near the stage area to help manage access.
  - 4. Jake shared Facebook ad performance: over 25K reach, almost 800 event responses, 60+ shares of the event series. Currently spending \$25/week in local targeting but could do more. Shannan mentioned that hashtags could help connect.
  - 5. A new T-shirt/uniform supplier is needed. Jake noted that Good Ink in Holland does fundraising online & does ship orders out.
- B. Speaking of Jazz To be resumed

- 1. Jordan noted that he will be resuming soon. After JITP ties up later this summer (August 23<sup>rd</sup>), it would be a good time to resume the series.
- 2. Jordan and Kevin will work on booking guests to list in the next newsletter. Fundraising events/masterclasses (tickets) will help boost the series.
- C. Federal/State Grants Jazz in the Park, Educational, Black History Month tabled
- D. Noto's Supper Club Update on resuming
  - 1. Jim will get a final word from them as the industry has still been struggling to re-open.
- E. Musician of the Year Event Watermark Country Club -12/6/21 Paul Brewer Ok'd the date and will get people to perform with him
  - 1. It will be a celebration party; it is a combination of MOY and the WMJS holiday party.
  - 2. Silent auction gifts need to start now, Shannan noted that a committee needs to be formed.

  - 1. They are still collecting funds. The granting committee still believes that WMJS may not fit their criteria for some of the funds awarded.
