- WMJS Board Meeting July 23, 2022
- Present: Michelle Needham, Jordan Van Hemert, Scott Freeman, Jim Reed, Shannan Denison, Jan Basham, Kevin Jones (until 10:00ish a.m.)
- Absent: Peni Reed, Jake Vanderheyden, Mary Rad (joined later)

- • Minutes from June: Jim suggested tabling it for next time Since Shannan just completed and sent them this morning.
- • Jazz in the Park Update:
- Jim gave an update and said we have another \$1800 from sponsors and donors. We are basically breaking even. Crowds weren't great for one of the concerts where rain was looming. Again the port-a-potty donation is BIG. Music has been great!
- Kevin Jones wants to have an Education Committee with Jason Proctor and Dr James Sawyer and Keith Hall from Western Michigan *Tuned In* wants to pick his brain about things. Jordan also offered to help with participation.
- Jan had asked Donna Kahny to proof the schedule. Jordan has a form for the artists to complete themselves.
- Jim asked for a volunteer to get all of the jazz stuff (table, chairs, signage, etc). Shannan said that she and Kevin would volunteer to house the jazz stuff since Kevin will be there early to set up sound and since we live close by.
- Jim also shared that our tent didn't last so we paid for a new tent \$750 which won't be there until the August concerts.
- • Update on FMG Arturo tickets: Michelle talked about how successful it has been and how excited the winners have been.
- • Betty Forrest Jazz Ambassador Award Event: September 26<sup>th</sup> honoring Kurt Ehinger. Noto's is not charging us a room fee for the event.
- Jake has a videographer who can help create something for Kurt's event. Jim suggested that we're setting a precedents with posthumously awarding Paul Smith MOY. Shannan and Michelle will meet offline to discuss the details of the event. Jordan asked about if it would be volunteered (the video) or if we can pay for it.
- Jazz Gumbos: Jordan has confirmed 5 dates, September, October and March, April, a mix of people who are newer along with Robin Connell and Doc Brewer for the opener. Scott Veenstra and Ramona Collins possibly, 3rd Coast Swing.
- Jordan proposed a "Rising Star" series for our newer musician students (18-27) maybe Elijia Crosby. He also asked for permission to hire Edye again for gumbo. The "Rising Star" series is good because it would help our grant application process and be a visible support of our mission
- Jazzing Up Our Legacy fundraising event in the Spring of 2023 update. Michelle spoke with Michelle and we need a big comittee with connections in the community for sponsors, etc.
- • Strategic planning: Michelle needs board matrix update from all board members
- Jazz Program Committee: Jordan likes the streamlined form from Dave V (website dude)
- Treasury Update: Michelle B is getting \$800 something a month for the next few months, we cannot take any \$ out we're not able to give out any earnings. Jim reported that the funds

were not available to give out scholarships. Additionally, we have not received applications for scholarships. Scott asked how much we have given out in the past and Jim said it varies between \$1000-\$3000.
